This document, including the 7-day barking dog diary, is required to assist Council in determining whether or not the noise created by the dog(s) could be deemed a nuisance under the definition of the Domestic Animals Act 1994:

Section 32 (2)(b) of the Domestic Animals Act 1994 provides that; "A dog or cat is to be regarded as a nuisance for the purpose of this section...If it creates a noise, by barking or otherwise, which persistently occurs or continues to such a degree or extent that it unreasonably interferes with the peace, comfort or convenience of any person in any other premises."
