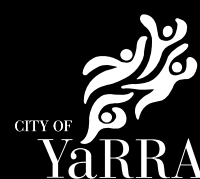

The Operational Supplement: Health and Wellbeing Activities 2021-25 (OSHWA) sets out the actions Council will undertake to protect, improve and promote public health and wellbeing in the City of Yarra.

The OSHWA is an output of Yarra's Council Plan 2021-25, which incorporates the Municipal Public Health and Wellbeing Plan (MPHWP). The OSHWA addresses our obligations under the Public Health and Wellbeing Act 2008.

There are six themes that underpin the MPHWP and OSHWA. These themes align to the Victorian Public Health and Wellbeing Plan 2019-23 (VPHWP) and connect across the Council Plan 2021-25.

The six themes are:

- Promoting gender equality and reducing gendered violence
- Promoting physical wellbeing
- Promoting community safety
- Promoting mental wellbeing
- Assisting to reduce the health harms from climate change
