1. That Council:
 - (a) acknowledges and thanks the State Government for its proposed investment in the North Richmond area and is pleased to see State Government attention and investment in such a significant precinct in the City of Yarra.
2. That in considering this matter, Council reaffirms its commitment to:
 - (a) retaining and expanding provision of open space in Yarra, and no net loss of open space; and
 - (b) retaining and increasing provision of public housing in Yarra, and that new housing on public land should be public housing.
3. That Council also reaffirms its various 25 January 2022 resolutions regarding the Richmond Housing Estate, and in particular reiterates its request for the State Government to establish a precinct structure plan for North Richmond "to holistically plan for the North Richmond area in future to both revitalise the area and better meet the needs of the current and future community".
4. That the Mayor write to the Minister for Housing and Minister for Planning and Minister for Energy, Environment and Climate Change to restate these Council positions and requests a meeting to discuss these particular topics.
5. That Council invites the State Government to partner with Council and other relevant stakeholders in exploring a new approach to governance, roles and responsibilities in the North Richmond precinct.
6. That Council note:

- (a) the officer report summarising the *North Richmond Draft Master Plan* currently being consulted on by Homes Victoria;
 - (b) the broad alignment of the draft Master Plan to Council's strategies and policies; and
 - (c) the draft submission prepared by Council officers to Homes Victoria as shown in Attachment Three, alongside a copy of this resolution and the refinements described below.
7. That Council endorse the submission in Attachment Three to be submitted to Homes Victoria on the North Richmond Draft Master Plan alongside the following matters that are to be expressed in writing to Homes Victoria and the Ministers for Housing and Planning and Minister for Energy, Environment and Climate Change to:
- (a) Transport:
 - (i) establish accessible tram stops on Church Street and on Victoria Street where they haven't been implemented already;
 - (ii) upgrade North Richmond and West Richmond train stations; and
 - (iii) assist Council in funding a permanent protected cycling infrastructure on Elizabeth Street (subject to successful completion of the trial), and overall streetscape enhancement works;
 - (b) Setbacks:
 - (i) establish built form setbacks to the following streets, with no projections into the setback area:
 - (1) Church Street - 2m setback.
 - (2) Elizabeth Street - 4m to the south side of Elizabeth Street, in addition to the currently proposed landscape setback on both sides of the street.
 - (3) Lennox Street - 3m setback;
 - (c) Accessibility:
 - (i) Build all new buildings to a minimum of silver standard accessibility requirements, with ease of adjustment to meet varied needs of occupants;
 - (d) Open Space:
 - (i) acknowledge the particular importance of retaining the community open space and the open space east and south of the south most tower (in the southern part of the Highett Street neighbourhood), as important community and event spaces and ensure the full extent of the existing community garden on Belgium Avenue and the rectangular open space directly south of this is retained; and
 - (ii) if open space is built over within the estate, offset the net loss of open space through provision of the same area of open space in Richmond, and work with Council to identify suitable State Government land holdings, or land for acquisition to facilitate this;
 - (e) Community Infrastructure:
 - (i) acknowledge the intention of the State Government to provide new community facilities and suggest that any new facilities include a multipurpose community hub with a new library;
 - (ii) establish interim solutions to facilitate enhanced service delivery as soon as possible on the estate; and
 - (iii) work with existing community service providers to establish more comprehensive funding programs and facilities to better meet community needs and further address safety and wellbeing;

- (f) Integration with Victoria Street:
 - (i) That the State Government create wide, activated, and direct through connections between Victoria Street to Elizabeth Street and the estate more broadly; and
 - (ii) Create a piazza for community events adjacent to one of the new through connections to Victoria Street and in proximity of the proposed new community hub;
- (g) Services:
 - (i) Underground overhead services throughout the estate, and on all boundary streets; and
 - (ii) Provide enhanced internet connectivity for current and future tenants;
- (h) Public Housing provision:
 - (i) That Council reaffirms its previous position that the State government should build significantly more public housing in Yarra on appropriate built-up sites that do not negatively impact on existing public housing residents or recreational or green space; and
- (i) Clarifications:
 - (i) confirm whether the new residential buildings will be “community”, “affordable”, or “public” housing, and provide Homes Victoria’s definition of those terms;
 - (ii) confirm the location of new, above-ground buildings on a map of the estate;
 - (iii) confirm the maximum heights of proposed residential buildings;
 - (iv) confirm that the State Government will retain 100% ownership of the properties in perpetuity; and
 - (v) confirm where and how adequate parking will be accommodated for current and future tenants.
- 8. That the Mayor write to the head of Homes Victoria, outlining the above matters, and seeking that consultation on the Homes Victoria North Richmond Draft Masterplan be extended with updated and more accessible information and engagement materials to afford greater engagement and understanding of the proposal within the local community, particularly public housing tenants.
- 9. That Council direct officers to:
 - (a) prepare a short report outlining high-level parameters of a precinct masterplan for the broader North Richmond precinct and to workshop this with Councillors as soon as possible; for the area generally bound by Highett Street, Hoddle Street, Newlands Street, Kent Street, Lambert Street, Baker Street, Johnston Street, Victoria Street, and the areas within Victoria Street Design and Development Overlays DDO 46-50;
 - (b) prepare a grant application to the Victorian Planning Authority (VPA) Streamlining for Growth Program - 2022-2023 Grant Program, to assist in accelerating the development and delivery of a precinct masterplan for the broader North Richmond precinct; and
 - (c) explore the parameters of the Department of Environment, Land, Water and Planning (DELWP) 20-minute neighbourhood Municipal Strategic Planning Project, and if applicable, prepare a submission to the Expression of Interest to participate for the broader North Richmond precinct.
