APPLYING FOR A PARKING PERMIT

When you apply for a new residential parking permit you must supply proof of residency and current vehicle registration. A visitor permit requires proof of residency only.

Examples of proof of residency:

- Copy of lease
- Contact of sale
- Rates notice (property and service address must be the same)
- Utilities bill (e.g. gas, electricity, home telephone -property and service address must be the same)
- Pension or Health Care Card

Examples of proof of registration:

- Copy of vehicle registration certificate (in applicant's name)
- Contract of sale (must show vehicle is registered)
- Copy of insurance documents (must list your name as a driver)

To apply for a City of Yarra parking permit you need to fill out an application form.

This form is available online at www.yarracity.vic.gov.au or by contacting our customer service team on 9205 5555.

Please make sure you read the parking policy. You then need to sign the application form to confirm you have read and understood the conditions.

Make sure you also date the application and enter the amount to be paid.

RENEWING YOUR PARKING PERMIT

Our parking permits are valid for 12 months. Before your parking permit expires, we will post you a renewal notice which will outline how to renew. However, it is your responsibility to renew your permit each year.

If your address and/or vehicle details have changed, you will need to advise Council as soon as possible. Please do so by completing a request online www.yarracity.vic.gov.au. Payment must be made prior to the permit's expiry date.

PARKING PERMIT PRICES Effective 1 July 2024

Residential and visitor parking permits

- First permit \$54.50
- Second permit \$132
- Third permit \$247

(pre-existing entitlement only)

Holders of a Health Care Card, Department of Veterans' Affairs Gold Card or Pensioner, War Widow and TPI concession cards receive the first permit for free. Second and third permits (if eligible) are charged at the first permit rate (\$52.00).

*Residential and Visitor permits are exempt from GST.

Business parking permits

- First permit \$153
for the first ten metres of street frontage or, if in a retail zone, for the first five metres of street frontage
- Second permit \$283.00
(based on an additional ten metre increment of street frontage)
- Subsequent permits \$283.00
(based on additional ten metre increments of street frontage)

Temporary resident parking permit

- Free

Medical practitioner parking permit

- First permit \$153
- Second permit \$283.00

Prices include GST where applicable.

Permit fees are refundable if a resident moves within the first six months of receiving the permit (calculated pro rata).

PAYMENT

Payment can be made:

- **Online**
If a parking permit was applied for online, payment must be made online once the application has been approved and the invoice has been emailed.

ADDITIONAL INFORMATION

- Area 25 is the Swan Street Carpark
- Area 50 is medical practitioner parking only

Parking permits DO NOT entitle the holder to park for a time longer than restricted or without paying fees in:

- Designated Shopping strips (refer to Parking Permit Policy October 2014 for which streets are designated)
- Time restricted spaces under 1 hour duration
- Paid parking (unless specified on the parking machine)

It's an offence to use or obtain a parking permit that has not legally been issued to you

Under the Yarra General Local Law you could be fined or have your permit cancelled, this includes if you are found;

- Selling, giving away or renting any parking permit
- Accepting or using any parking permit that has not been officially administered by Council
- Forging or counterfeiting any vehicle permit or knowingly distributing a forged or counterfeit vehicle permit
